Blue-White Screening (Terminal Integrity) - A sample of pUC19 vector linearized with a 10-fold excess of SphI-HF TM , religated and transformed into an <i>E. coli</i> strain expressing the LacZ beta fragment gene results in <1% white colonies.	Pass
